SERVICE PROVIDER TRAINING SESSION

An introduction to Enduring Powers of Guardianship and Advance Health Directives

On 15 February 2010 legislation came into effect in WA which enables adults to make an **Enduring Power of Guardianship (EPG)** and an **Advance Health Directive (AHD)**.

These tools give adults with capacity, the power to direct how personal, lifestyle and treatment decisions would be made if they lost the capacity to make these decisions themselves.

Following the session, participants will have an understanding of:

- the amendments to the *Guardianship and Administration Act 1990*
- the legislative requirements of completing an EPG and an AHD
- how EPGs and AHDs will operate
- the amended hierarchy of decision-makers for treatment decisions
- the legal responsibilities of service providers with regard to the new legislation and how they will be able to assist their clients.

This session is aimed at service providers in the health, aged-care disability and related sectors, however members of the public who are interested in attending are also welcome.

GPs to drive Australian Lung Census

General Practitioners (GPs) are being urged to assess the lung health of 50,000 adults as part of the largest screening of lung function to be undertaken in Australia.

The Lung Census – a joint initiative of The Australian Lung Foundation, the Royal Australian College of General Practitioners, the Improvement Foundation, and MediMark International – will be conducted from 4 -15 October 2010 to support and promote Global Test Your Lungs Day (14 October) and the Year of the Lung.

The Lung Census will seek to identify thousands of individuals who would benefit from fuller medical follow-up with regard to Chronic Obstructive Pulmonary Disease (COPD).

COPD is a leading cause of death and disability in Australia affecting over one million sufferers of whom 50% are undiagnosed.¹⁻³

"We are very excited by this National initiative which will raise the awareness of the importance of lung function testing, and place the earlier identification of COPD firmly on the National health agenda," said Professor Peter Frith, Chairman of the Australian Lung Foundation's COPD Coordinating Committee.

"We are grateful for GPs' commitment to this important initiative to acquire an insight into the state of the nation's lung health," said Professor Frith.

The Lung Census was developed following the success of the CLEAR Program – a pioneering respiratory education initiative for GPs and their Practice Nurses that demonstrated the practicality and value of simple screening of lung function.

To reach the Lung Census target GPs will be asked to screen 25 patients aged 18 years and over during the two-week Lung Census period. Screening will involve a simple Screening Questionnaire followed by an assessment of lung function using the PiKo-6 handheld, electronic lung health meter. This will identify patients who may benefit from a fuller medical assessment.

GPs can find out more about the Lung Census and register to take part by visiting www.lungcensus.com.au, this should be done as soon as possible to ensure receipt of screening material and PiKo-6 lung health meter in time for the Lung Census.
